Minutes of Meeting of the Board of Directors  
August 21, 2012**

The Board of Directors of Chisholm Trail Special Utility District of Williamson, Bell, and Burnet Counties, Texas convened at a designated meeting place for the District, at the Georgetown Chamber of Commerce, 100 Stadium Drive, Georgetown, Williamson County, Texas beginning at 6:00 p.m. on the 21<sup>st</sup> day of August, 2012. **Reconvened**


**The Board reconvened the meeting at 6:45 p.m. with all Directors present.**
